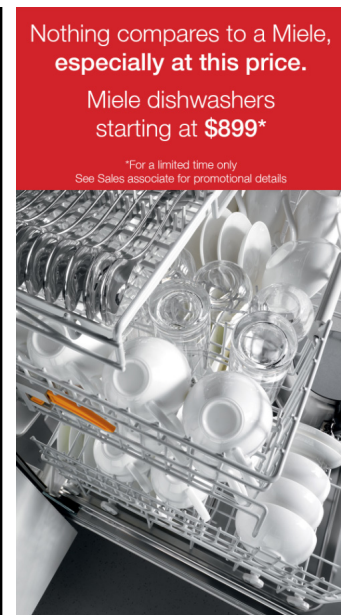
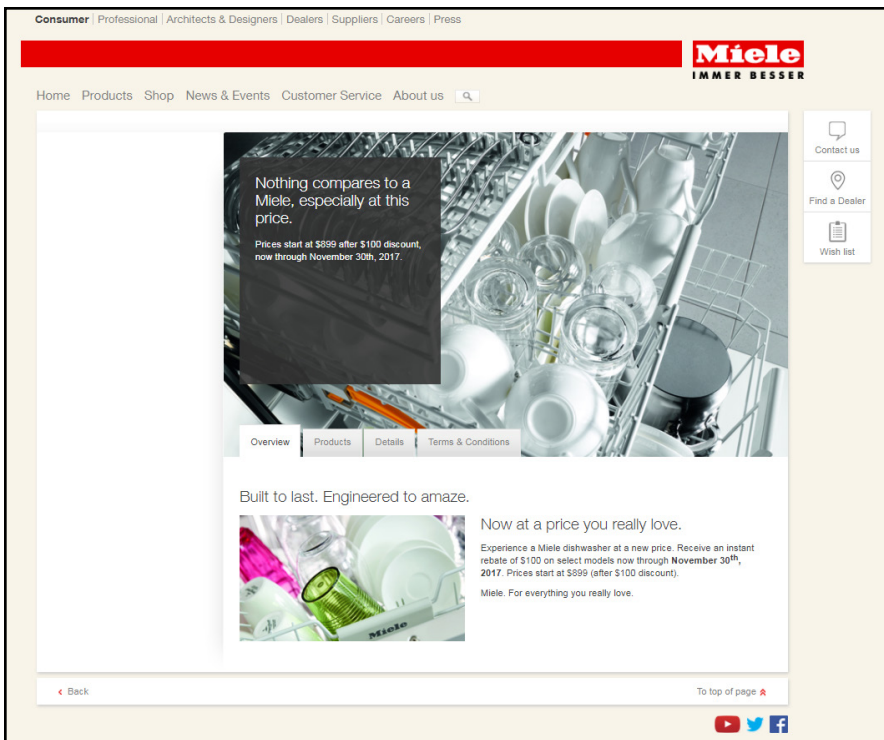

(6) To qualify for the Discount, the Qualifying Appliance must be ordered in person at the store of an authorized Miele dealer or by phone to the same or online through a participating authorized Miele dealer’s website from October 1, 2017 through and including November 30, 2017 (EST) (the “Discount Period”). (7) Purchases made on or before September 30, 2017 shall not qualify for the Discount. Purchases made on or before September 30, 2017, and subsequently cancelled and reissued during the Discount Period shall not qualify for the Discount. Purchases made during the Discount Period and subsequently cancelled and reissued after the Discount Period shall not qualify for the Discount. (8) In the event a Qualifying Appliance is returned to Miele or a Miele dealer after a Discount has been credited, the Discount shall be forfeited and must be refunded to Miele in its entirety at the purchaser’s expense. (9) The Discount on the Qualifying Appliance shall be limited to one (1) Discount per household except in Rhode Island or where prohibited by law. (10) The purchaser shall be eighteen (18) years or older. (11) The Discount shall be voidable at any time at Miele’s discretion if the retail end user violates the applicable rules.
