**TERMS AND CONDITIONS OF SALE**

**PRICES**

All prices in US \$. Goods will be invoiced at prices ruling on the date of despatch. All previous Price Lists are now cancelled.

Prices are subject to alteration without notice.

**PAYMENT TERMS**

Payment is due 30 days from invoice date.

**ADDITIONS TO ORDERS**

We process all customer orders upon receipt and are therefore unable to accept any addition to orders or cancellations once the order has been received.

Claims for non-delivery, shortages or damage to goods cannot be entertained unless we and the carriers are notified in writing within 7 days from the date of receiving the goods. Claims will not be accepted where customer has requested a third-party delivery address.

**GOODS RETURNED FOR CREDIT**

**(No merchandise can be accepted at the New York Customer Service Center).** All requests for RGAs must be made within 30 days of receipt of delivery. Requests must first be agreed to and authorized by the representative. Goods authorized for return will be subject to a minimum handling charge of 25% subject to the condition of the goods and packaging. The customer is to arrange and pay the freight to the United Kingdom. Once inspected and approved the goods will be credited. Any reordered goods will be billed at the prices ruling on the day of despatch. Special order items will not be accepted for return. The dealer must assume responsibility for all unauthorized and authorized customer returns ensuring they are re-boxed.

**RETENTION OF TITLE**

Ownership of goods shall remain in the Company until full payment has been received for all goods comprised in this contract. If any goods are re-sold before payment is made the Company's right of ownership shall be transferred to the proceeds of sale or to the claim for such proceeds.

**QUOTATIONS**

Quotations issued by Samuel Heath are indicative only and not binding. Unless a period of validity is stated, this should be considered as one month.

**PAYMENT**

Payment must be made to Samuel Heath in accordance with the invoice terms for the product warranty to be valid.

**SPECIAL ORDERS**

Agreement must be reached in writing. A signed special order form must be received from the customer in order for production to commence. Upon receipt of this signed order there can be no deferment or cancellation and the customer is bound to pay the full amount due.

**LIABILITY**

All quotations are given and goods sold subject to the conditions that the seller's liability is limited to goods proved to have been defective in material or workmanship when they left the seller's works. No claim will be accepted where goods have been used for the purpose for which they were not intended, not fitted correctly, not maintained to the seller's recommended standards or have been abused or misused. Samuel Heath's liability is limited to the replacement of the faulty product only and does not allow for claims for other costs such as damage to products supplied by Samuel Heath or for working hours or for repairs.

**APPLICABLE LAW**

The terms and conditions are in accordance with UK law and all claims must be made under the jurisdiction of UK law.

**FINISHES**

The finish of the product must be cared for in accordance with Samuel Heath's Care instructions (copy available upon request). Abrasive cleaners must be avoided. Variations in natural metal finishes such as unlacquered brass and bronze are unavoidable in the production process and do not constitute a reason for return of the product.
