AGA UMRP Policy: AGA Products may not be advertised at a price that is below the UMRP price that AGA has established for the brand. Please refer to the current AGA Dealer Price list for UMRP pricing.

DISPLAY PRICING: Dealers placing orders for new AGA display units can purchase at 35% off regular Dealer price.

MULTIPLE LOCATIONS: Dealers with branch operations must have complete AGA displays in each authorized location. Branches without AGA displays are NOT authorized to quote or sell AGA products in any manner.

FREIGHT PROGRAM- CURBSIDE DELIVERY to the Dealer's Warehouse. AGA purchases equal to \$6,000 or more will earn prepaid freight. All shipments less than \$6,000 will be charged 3.5% of invoice (minimum \$80 charge).

- Accessories Ride FREE with Major Units FREE
- Accessories, shipped alone F.O.B.

FREIGHT EXCEPTIONS:

- Shipments from a Middleby Residential Distributing warehouse other than our designated warehouse are FOB shipping point (dealer pays full freight).
- Any special requirements, such as lift gates, elevator access, etc. will incur an extra charge.
- Shipments to the mainland consolidator for Alaska or Hawaii will fall under the above guidelines.
- Shipments directly to AK and HI are FOB Chino, CA (dealer arranges freight carrier).

Return Goods: All returned goods must have an RMA number issued prior to shipping. Please Obtain an RMA number prior to return directly from your inside sales person. All returned goods are subject to a minimum 25% re-stocking fee and return freight prepaid. Returns are not allowed after 30 days of initial shipment.

PROGRAM CONDITIONS

- Displays must be maintained to earn incentives and will be inspected at the beginning of each quarter.
- All display items must be current AGA Products and displayed in clean and maintained displays.
- Special Lot pricing discounts are based on orders placed on a single purchase order and shipped to a single location.
- Special Lot pricing will be applied to stocking orders only. Products purchased for displays must be on a separate P.O. and can't be combined with stocking orders.
- Dealer must keep their Open Account current to earn special Lot pricing discounts. Any purchases that are not paid within the Net 30 day terms stated on the invoice will revert back to the single lot price.
- Dealer Sales Volume used for this program is per the sales records of Middleby Residential Distributing.
- This program supersedes all previously published programs.
- This program is subject to change or cancellation with written notice.
